This prospectus supplement (the "Prospectus Supplement") to the base prospectus dated 20 June 2014 prepared by Goldman, Sachs & Co. Wertpapier GmbH ("GSW") as issuer, Goldman Sachs International ("GSI") as issuer and The Goldman Sachs Group, Inc. ("GSG") as guarantor under their programme for the issuance of warrants, notes and certificates with respect to the securities (the "Programme") (the "Original Base Prospectus"), constitutes a supplement to the base prospectus for the purposes of Article 13 of Chapter 1 of Part II of the Luxembourg Law on Prospectuses for Securities dated 10 July 2005 and amended on 3 July 2012 (the "Luxembourg Law") and should be read in conjunction therewith and with Prospectus Supplement No. 1 to the Base Prospectus, dated 17 July 2014, Prospectus Supplement No. 2 to the Base Prospectus, dated 8 August 2014, Prospectus Supplement No. 3 to the Base Prospectus, dated 28 August 2014, Prospectus Supplement No. 4 to the Base Prospectus, dated 3 September 2014 and Prospectus Supplement No. 5 to the Base Prospectus, dated 17 October 2014 (the Original Base Prospectus as so supplemented, the "Base Prospectus"). On 20 June 2014, the Commission de Surveillance du Secteur Financier (the "CSSF") approved the Original Base Prospectus for the purposes of Article 7 of the Luxembourg Law.
