## **This Supplement**

This supplement (the "Supplement") to the registration document dated 20 June 2014 prepared by Goldman, Sachs & Co. Wertpapier GmbH ("GSW") as issuer, Goldman Sachs International ("GSI") as issuer and The Goldman Sachs Group, Inc. ("GSG") as guarantor of certain warrants, notes and certificates (the "Original Registration Document"), constitutes a supplement to the Registration Document for the purposes of Article 13 of Chapter 1 of Part II of the Luxembourg Law on Prospectuses for Securities dated 10 July 2005 and amended on 3 July 2012 (the "Luxembourg Law") and should be read in conjunction therewith and with Supplement No. 1 to the Registration Document, dated 16 July 2014, Supplement No. 2 to the Registration Document, dated 8 August 2014 and Supplement No. 3 to the Registration Document, dated 28 August 2014 (the Original Registration Document as so supplemented, the "Registration Document"). On 20 June 2014, the Commission de Surveillance du Secteur Financier (the "CSSF") approved the Original Registration Document for the purposes of Article 7 of the Luxembourg Law. The terms defined in the Registration Document have the same meaning when used in this Supplement.

# Information being supplemented

This Supplement supplements the Registration Document by incorporating by reference in its entirety the unaudited half-yearly financial report of GSI for the period ended 30 June 2014 ("GSI's 2014 Interim Financial Statements"). A copy of GSI's 2014 Interim Financial Statements has been filed with the CSSF in its capacity as competent authority under the Prospectus Directive.

GSI's 2014 Interim Financial Statements is by reference incorporated into, and forms part of, this Supplement, and the information contained in this Supplement, and GSI's 2014 Interim Financial Statements shall be deemed to update and where applicable, supersede any information contained in the Registration Document, or any documents incorporated by reference therein.

This Supplement and the document incorporated by reference into this supplement will be available on the website of the Luxembourg Stock Exchange at www.bourse.lu.

# **Additional information**

As at 30 June 2014 current assets were USD 883,371,098,000 and as at 31 December 2013 current assets were USD 816,202,624,000 (USD 891,299,754,000 as at 31 December 2012). As at 30 June 2014 the total shareholders' funds were USD 21,183,148,000 and as at 31 December 2013 the total shareholders' funds were USD 20,300,471,000 (USD 20,193,453,000 as at 31 December 2012)."
