This prospectus supplement (the "Prospectus Supplement") to the base prospectus dated 13 January 2023 prepared by Goldman, Sachs & Co. Wertpapier GmbH ("GSW") as issuer, Goldman Sachs Finance Corp International Ltd ("GSFCI") as issuer, Goldman Sachs International ("GSI") as issuer and as guarantor in respect of certain Securities only and The Goldman Sachs Group, Inc. ("GSG") as guarantor in respect of certain Securities only (the "Original Base Prospectus") under their Series P programme for the issuance of warrants, notes and certificates with respect to the Securities (the "Programme"), constitutes a supplement to the Base Prospectus for the purposes of Article 23(1) of Regulation (EU) 2017/1129 (as amended, the "EU Prospectus Regulation") and should be read in conjunction with Prospectus Supplement No. 1 to the Original Base Prospectus dated 30 January 2023, Prospectus Supplement No. 2 to the Original Base Prospectus dated 14 February 2023, Prospectus Supplement No. 3 to the Original Base Prospectus dated 15 March 2023, Prospectus Supplement No. 4 to the Original Base Prospectus dated 5 May 2023, Prospectus Supplement No. 5 to the Original Base Prospectus dated 12 May 2023, Prospectus Supplement No. 6 to the Original Base Prospectus dated 12 June 2023, Prospectus Supplement No. 7 to the Original Base Prospectus dated 20 July 2023, Prospectus Supplement No. 8 to the Original Base Prospectus dated 26 July 2023, Prospectus Supplement No. 9 to the Original Base Prospectus dated 18 August 2023, Prospectus Supplement No. 10 to the Original Base Prospectus dated 6 September 2023, Prospectus Supplement No. 11 to the Original Base Prospectus dated 19 September 2023, Prospectus Supplement No. 12 to the Original Base Prospectus dated 11 October 2023, Prospectus Supplement No. 13 to the Original Base Prospectus dated 20 October 2023, Prospectus Supplement No. 14 to the Original Base Prospectus dated 3 November 2023, Prospectus Supplement No. 15 to the Original Base Prospectus dated 28 November 2023 and Prospectus Supplement No. 16 to the Original Base Prospectus dated 1 December 2023 (the Original Base Prospectus as so supplemented, the "Base Prospectus"). On 13 January 2023, the Original Base Prospectus was approved by the Commission de Surveillance du Secteur Financier (the "CSSF") for the purposes of Article 6 of the Luxembourg Law dated 16 July 2019 on prospectuses for securities and by the Luxembourg Stock Exchange pursuant to the rules and regulations of the Luxembourg Stock Exchange for the Luxembourg Stock Exchange's Euro MTF market.

Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement unless otherwise defined herein. This Prospectus Supplement shall form part of and be read in conjunction with the Base Prospectus.

Right of withdrawal
